Dear Bigo Live Safety / Compliance / Management Team,

I am contacting you as a concerned EU citizen to report serious safety and policy violations occurring on the Bigo Live platform, and to inform you that this evidence is now being organised and prepared for broad public exposure.

Over the last months I have documented:

- public live streams involving alcohol consumption and “drinking challenges” in exchange for virtual gifts (beans);
- sexualised and borderline explicit content visible without login, meaning any minor can watch it with a simple click;
- suspicious “gift / bean” transfers between linked accounts, apparently used to fake earnings and targets;
- chats that suggest emotional and financial exploitation of viewers.

To make these risks transparent, I have created an independent public report at:

All screenshots and descriptions come from Bigo Live's public interface, without hacking or bypassing technical protections. No real-world personal identities are exposed; only what any user can see inside the app.

This website is not intended to harass any specific streamer. It documents platform-wide moderation failures and safety risks, especially for minors who can freely access this content.

Regardless of your internal response, starting tomorrow I will begin actively sharing this material with:

- EU and national regulators and child-protection bodies,
- investigative journalists and mainstream media,
- and through major social media platforms.

In other words, the time for treating this as a harmless "show" is over. From now on, there will be public scrutiny of what Bigo Live allows to happen in front of minors and vulnerable users.

I respectfully ask Bigo Live to:

1. Review the material documented on darkbigo.com and compare it with your own Community Guidelines and safety policies.
2. Investigate the accounts and agencies involved in alcohol-based challenges, sexualised performances and suspicious bean transfers.
3. Strengthen moderation and age-control mechanisms so that this type of content is no longer freely available without login.
4. Provide a written response explaining what concrete measures Bigo will take, and in what timeframe, to address these risks.

This is not a threat and not an attempt at blackmail. It is a formal warning that the situation is now documented, public, and will be brought to the attention of the press and relevant authorities.
