Dear Bigo Live team,

Following your response to case #203930, we formally state that your company's conduct reflects a structural form of concealment, institutional negligence, and potential complicity in digital and fiscal crimes within the European Union.

From the very beginning, the DarkBigo project acted with full responsibility. We submitted legitimate, transparent, and verifiable evidence. Subsequently, we deployed an external AI agent that operates without collecting images or video, using metadata only, based on your own public guidelines. This agent accesses the platform as a guest—just like any minor can today from Europe.

In less than three hours, the AI identified over: – 1,800 streams with sexualized content (dancing, partial nudity, masturbation simulation); – 100+ streams with alcohol consumption in exchange for virtual currency ("send beans, I drink"); – 400 profiles offering intimate content ("X beans = new photos/videos"); – dozens of invitations to paid private sessions.

All of this was publicly available via guest access, with no login, no age barrier, and accessible from EU territory.

This is not hypothetical. This is based on real-time evidence—evidence we already possessed at the time we sent our first list of user IDs with a 72-hour deadline for corrective action. You were given the opportunity to demonstrate good faith. Instead, you chose to obscure or selectively act, while continuing to allow the broader pattern.

We now confirm: all previously reported IDs are archived with metadata and are being submitted to competent authorities.

On age verification: You claim Bigo Live is for users "18+." Then prove it. If your app allows unrestricted guest access, then you have no basis to assert that there are no minors accessing the content. ****How do you prove that there are no minors watching sexualized or monetized content on your platform? You can't.****

Claiming that "it's not a problem in other countries" is irrelevant. You broadcast into the European Union, where: – public sexual exhibitionism accessible to minors is illegal, – incentivizing alcohol consumption with digital coins is illegal, – soliciting sexual services via private exchanges is illegal, – failure to implement age-gating is a violation of DSA requirements.

You do not have regional filters or effective AI moderation. And if your AI truly worked, it would have blocked or suspended such users—just as our AI, with no internal access, detected the violations.

****The only reason your AI doesn't block them is because you don't want it to.****

On app store deception: Is your app listed on Apple and Google Play as an adult-only service? No. It's classified as a general-use social media app. That is ****deceptive distribution****. It places inappropriate content one click away from minors, without age-gating, while your policies claim otherwise.

On economic responsibility: Streamers who work hours per day, receiving coins turned into real money, are engaging in professional activity. If Bigo or affiliated agencies fail to disclose tax obligations, social security registration, and proper employment classification, you are complicit in

Thank you for taking the time to report your concerns and for providing supporting materials.

We confirm that your submission has been formally received and the case number is#203930. All identifiable accounts referenced in your report have been reviewed by our content monitoring team within the relevant review window.

As a result, enforcement actions have been applied to some of the reported accounts in accordance with our Community Guidelines. Other accounts have already been subject to enforcement measures and remain under further review, including escalation assessment, to determine whether additional action is warranted. For privacy, safety, and compliance reasons, we are unable to share account-level enforcement details or outcomes.

Bigo Live is intended for adult users, and access by minors is against with our policies. In light of evolving regulatory expectations and differing legal requirements across jurisdictions, we continue to evaluate and enhance age-related safeguards as part of our broader compliance and safety framework. In parallel, we are refining content recommendation and distribution processes, including in guest access scenarios, to further reduce the potential exposure of age-inappropriate content.

We appreciate your engagement and the role responsible reporting can play in improving platform safety.

If you have any additional information that you consider relevant, you may submit it in accordance with our standard procedures, and it will be reviewed accordingly.
